Terms

<u>Client:</u> Anyone seeking to engage with The Paint Palette Co. for the purpose of providing paint color or design related services.

Designer: Megan Paterson, Owner and Interior Designer at The Paint Palette Co.

<u>Colors and Designs:</u> All recommendations, suggestions and equivalent color and design related information and material provided by the Designer to the Client, regardless of the format <u>E-DESIGN AND COLOR PLANS:</u> Documents in electronic format (e.g., PDF) that contain design guidance and color recommendations and that are provided to Clients following the purchase of a paint color or interior design e-service.

Client Obligations & Terms of Use

- Clients are responsible for confirming the accuracy and completeness of any information that is provided to The Paint Palette Co.
- Clients are responsible for contacting The Paint Palette Co. and clarifying any questions or concerns prior to submitting payment.
- After checkout or after an invoice is payed by the Client, the Client must respond to The Paint
 Palette Co. immediately to discuss the paint color or design services. Once submitted and the
 designer begins works, if there are any significant or substantial changes that affect the design,
 the Client may incur an additional fee or charge at the discretion of the designer.
- For any Service that includes a post consultation phone call to go over the designer's recommendations and suggestions, you must provide The Paint Palette Co. with a valid phone number and schedule your phone consultation within 7 calendar days after receiving your completed purchase or else you forego the opportunity to speak with a designer over the phone. In that case, it will be at the discretion of the designer (subject to their availability) to determine whether they can accommodate a follow up.
- The Paint Palette Co. takes data security and privacy very seriously and has multiple measures
 (as described in the "Data Security" section) to keep information safe, however it is the ultimate
 responsibility of each Client to ensure that they are comfortable with the information that they

- provide to us, including, reviewing and cleansing all data (e.g., form responses, photos, documents, etc.) of any personal information or other data that they do not wish to share.
- Client understands and agrees that color and design plans are based on the Designer's
 professional expertise, judgment and experience. Client further understands and acknowledges
 that all color plans and designs are recommendations that the designer has created from the
 information provided by the Client.
- Client understands and agrees that The Paint Palette Co. maintains the right to deny service
 and/or cease service and refund payments as deemed appropriate (for example, in situations
 where a Client cannot be reached for extended periods of time, or where The Paint Palette Co.
 is unable to obtain information necessary for the completion of work).

THE PAINT PALETTE CO. COLOR PLANS AND DESIGNS

- Revisions Due to the highly specialized and custom nature of each THE PAINT PALETTE CO. COLOR PLANS AND DESIGNS they cannot be modified or amended once they are finalized and provided to the Client; however, if the Client is not satisfied or has a valid reason for requesting additional information, the designer will often be able to make alternative suggestions and recommendations either via phone or email. On a case by case basis, should the Client have any concerns or issues with the THE PAINT PALETTE CO. COLOR PLANS AND DESIGNS, the designer may make certain amendments (subject to limitations) and only if the updates can be made fairly quickly and easily. Provision of Color Plans and Designs by the Designer for THE PAINT PALETTE CO. Services

- Color plans and designs will be based off of the information and details provided by the Client
 and will be delivered by the designer to the best of their ability and professional experience. All
 Color plans and designs are personal recommendations based on each Designer's professional
 experience and judgment.
- Color plans and designs are heavily impacted by the indicated budget. In order to meet budget expectations, unless specified otherwise by the Client, THE PAINT PALETTE CO. may choose to focus on particular rooms and/or to work with existing Client items, which are not specifically mentioned by the Client. If the designer does not provide recommendations for a room (or other aspects indicated by the Client) it is because the designer felt that the Client's spending was better allocated in other areas based on the Client's preferences and needs. Should the Client then decide that they would like to include additional designs, such modifications will be subject to the consent and pricing agreed to by the Designer.

Implementation of Color plans and designs by Designer for THE PAINT PALETTE CO. Services

- Implementation of Color plans and designs (e.g., how the Client decides to use the designs), including the purchase of items and materials, is the sole responsibility of the Client.
- THE PAINT PALETTE CO. is not responsible for any changes to prices or costs from those prices or costs listed in any Color plans and designs.
- Measurements and dimensions: As all measurements and dimensions are provided to THE
 PAINT PALETTE CO. by the Client, THE PAINT PALETTE CO. is not responsible for any
